TERMS & CONDITIONS

1. This contract provides Planet Groove for a total of 6 hours from the time Planet Groove arrive at the Venue to the completion of the last set. Note the band usually needs between 90-120 minutes to setup and soundcheck.
2. In the event additional time is required an additional fee will be charged for overtime in excess of 6 hours on call time
3. This contract provides a total of maximum three (3) music brackets with a maximum duration of 45 minutes each.
4. In the event additional time is required an additional fee will be charged for overtime.
5. Additional time can only be requested by the client or nominated representative to ensure additional charges are not incurred without your authority.
6. Each Planet Groove member (6) + (1) Production/Audio Manager must be provided with one staff meal and non-alcoholic drinks during non performance times.
7. The event organizer must confirm if any sound restrictions are in place with the venue. Planet Groove and our Audio/Production manager will endeavor to meet all requirements; however the band usually plays at ~ 105dB to ensure good acoustics.
8. Payments must be made in full 14 days prior to the date of the event.
